OMAN

REQUIREMENTS

TRADE/SERVICE MARK

- 1. A power of Attorney, duly legalized up to the Omani Consul.
- An Extract from the Commercial Register or Articles of Incorporation, or any equivalent document, duly legalized up to the Omani Consul.
- 3. 10 Prints of the mark.

PATENTS

- 1. A Power of Attorney from the applicant, duly legalized up to the Omani Consul.
- 2. If the applicant is different from the inventor, an Assignment from the inventor(s), legalized up to the Omani Consul.
- 3. Specification, claims, abstract and formal drawings, if any, in English.
- 4. An Extract from the Commercial Register or Articles of Incorporation, or any equivalent document.
- 5. Copies of the International search report and preliminary examination, copy of the PCT application as published.

Assignment

- 1. A Power of Attorney from the Assignee, duly legalized up to the Omani Consul.
- 2. A Deed of Assignment, signed by both parties, duly legalized up to the Omani Consul.
- 3. An Extract from the Commercial Register or Articles of Incorporation from the Assignee, or any equivalent document, duly legalized up to the Omani Consul.

Change of Name and/or Address

- 1. A Power of Attorney in the new name and/or address duly legalized up to the Omani Consul.
- 2. A Certificate of Change of Name and/or Address, legalized up to the Omani Consul.

Merger

- 1. A Power of Attorney from the entity surviving the merger, duly legalized up to the Omani Consul.
- 2. A Certificate of Merger, duly legalized up to the Omani Consul.
- An Extract from the Commercial Register or Articles of Incorporation, or any equivalent document, duly legalized up to the Omani Consul.

Licensing

- 1. A Power of Attorney from the licensee, duly legalized up to the Omani Consul.
- 2. A copy of the License Agreement, duly legalized up to the Omani Consul.
- 3. An Extract from the Commercial Register or Articles of Incorporation from the Licensee, or any equivalent document, duly legalized up to the Omani Consul.

DESIGNS (Cautionary Notices)

- 1. Particulars of the owner, such as name, address, nationality and nature of business.
- 2. The title and drawings of the design, supported by brief description.
- 3. Particulars of corresponding foreign registration(s), if any.

COPYRIGHTS

- 1. A Power of Attorney, duly legalized up to the Omani Consul.
- An Extract from the entry of the applicant in the Commercial Register, or any equivalent document, duly legalized up to the Omani Consul.
- 3. A Certified copy of home or any foreign registration of the copyright.
- 4. Three copies of the work.

DOMAIN NAMES

- 1. A Power of Attorney from the Applicant, duly legalized up to the Omani Consul.
- An Extract from the entry of the applicant in the Commercial Register, or any equivalent document, duly legalized up to the Omani Consul.
- 3. Particulars of the owner of the domain name.
- 4. A certified copy of the License Agreement, if the Domain Name denotes a licensed trademark.
- 5. Primary Server IP Address.
- 6. Secondary Server IP Address.
- 7. Authorization letter from the Applicant.
